CITY COUNCIL MEETING
SEPTEMBER 16, 2019**

MAYOR STEVE DOBOSH CALLED THE MEETING TO ORDER. THE FLAG SALUTE WAS LED BY MAYOR DOBOSH.

COUNCIL MEMBERS PRESENT: Emily Morgan, Glenda Forga, Carol Hill via phone, and Ron Neumann. Guy Spratt was absent.

EMPLOYEES PRESENT: Michelle Whitten, City Clerk and John Brockmueller, Police Chief.

CONSENT AGENDA APPROVING CITY COUNCIL MINUTES OF SEPTEMBER 3, 2019. Emily motioned to approve the consent agenda; Glenda seconded. Motion carried unanimously.

DEPARTMENT REPORTS:

Steve Dobosh – Mayor: Steve met with Commissioner Jackson and Lions Club regarding South County Park and alternatives for water aeration to help control the algae. It was a good meeting and looking at ways to make it a public park again. He also spoke with Jeff Landrum who is a science hydrologist who is looking into the park and water quality solutions.
