CITY COUNCIL MEETING
September 21, 2020**

Mike explained that the rain water runs into the stormwater system which directly goes to the river. There is no treatment for the stormwater. Emily commented that the water did drain from the streets quickly.

Steve asked if the polymer is being tested yet and how long will it take. Mike said they are starting the testing the different polymers this week. Each type will take a couple of days, and they have three to do.
