**MEMBERS PRESENT:** Jamie Cummings, Mike Morgan, Jill Davis, and Mike Fisher.

**CALL TO ORDER:** The meeting was called to order by Chairman Jamie Cummings.

**APPROVAL OF MINUTES:** Jill made a motion to approve the June 09, 2021 meeting minutes, Jamie seconded the motion. Motion carried unanimously.

**SECRETARY’S REPORT:** The automatic locks at the boat launch are not working. We are looking into replacements.

**NEW BUSINESS: Park Improvements.** After previous talks the board agreed to not place fire pits in each campsite but construct a larger “community” fire pit in the park. The board agreed that the location of the fire pit should in the open area to the west of the horseshoe pits and behind the wood shed. They would like to see the pit be made of landscaping blocks and have gravel around the outside of the pit.

Jill made a suggestion to possibly add something to the blank area to the west of the RV dump station. Currently the grassy area is unused. She suggested adding a half court basketball set up. This would provide something for the older kids and even the adults that visit the park.

These suggestions will be added to the updates to the Park Plan in the upcoming months.

**OLD BUSINESS: Jail Improvement Update.** This project is substantially completed. The water system has been finished and is working well. Miscellaneous items are still needed such as a metal arbor, table, and the mural on the wall.

**Boat Launch Sign.** No progress has been made.

**RV Campsites.** The road for the campsites was rocked. The project is almost completed. A few items that are still needed are new numbers for the posts and a new post for site 13. The parking area will still need to be graveled at some point.

**6<sup>th</sup> Annual Esther Borte Walk in The Park.** Online registration is open at Eventbrite.com. Sponsor letters are going out this month.

**Park Host Agreement.** Jamie is working on making changes/suggestions to the agreement. The board agreed that they would like to add a 3-year term to the agreement and the host would have to reapply at the end of each term.
