Hi Chief Lawrence-

The salary info is good, but typically staffing and salaries are seen as a function of general fund/city budget. Although the proposed subdivision would cause an increase in the service calls and result in the need for additional officers, I don't believe we can request for staff through SEPA. I do think I can use your message below to show the need for additional officers, and with additional officers' equipment is needed. I'd like to try to include some of the cost of that in a SEPA mitigation condition. Do you have a list of equipment that an officer would need to serve the city with an idea of approximate cost? That one-time payment would be more consistent with a SEPA mitigation than salaries, although I will use this in our SEPA review as a SEPA comment.

Also, is there some data source that shows a recommendation for number of officers per capita for rural communities?

### Greetings

The City of Toledo Police Department would like to offer the following information data for consideration regarding the impact of about 100 new homes and the addition of about 325 citizens and how this may impact the services of Toledo Police Department.

- There are about 720 citizens within or near the borders of the Cit of Toledo
- With an estimated 325 additional citizens using a 2.7 per household formula (conservative estimate) this would push the population to about 1.045
- When trying to estimate growth the formula of "change in population size = (births + Immigration (deaths + emigration) is a commonly used standard
- Rural areas traditionally have more children than cities
- A recent United States Census study shows in the Western rural area's there was a growth in population of about 13.3%
- The median age estimate of the City of Toledo is 42.7 years of age
- With the potential added 100 homes using the growth formula and referencing the Census study of 13.3% growth we can expect most of the new homeowners to be younger than the current median age

The "SEPA" impact of the projected growth of new 100 homes should also factor in the additional traffic in and around downtown Toledo. We currently have had major issues and complaints of recreational vehicles, motorcycle riders attending the "racetrack" outside the City of Toledo speeding through the City. We should also factor in whenever a blockage occurs on Interstate 5, freeway traffic is diverted through the City of Toledo.

As the Chief of Police, it is my responsibility to protect serve the City of Toledo, population, and ensure public safety with staffing needs now and in the projected future.

To accomplish this responsibility, it is my recommendation the City of Toledo have at a minimum the following staff in place for public safety with the projected growth

- Chief of Police (Salary already established)
- Patrol Sergeant 65K (not funded yet)
- Senior Officer 60K (not funded yet)
- Patrol Officer 55K (not funded yet)

These conservative numbers are about the middle of the road numbers.
